Dear Imran Kazmi,

Thank you for your contact. PANA is only a friendship association based in Islamabad and have unfortunately limited capacity to interfere in consular matters in UAE or even here in Pakistan. Your appeal application can only be processed and decided by the appropriate immigration authorities in Norway (e.g. UDI or UNE).

However, I would like to express to you that the problem of visa discrimination for Pakistani applicants is sadly far too common. You are true to point out that the rejection of your/wife/childs visas application was mainly due to the generalized discriminatory practices, which far too many Pakistani citizens have to endure when they apply for Norwegian and Schengen entry. PANA have on many occasions in the past expressed our concern about these generalising and discriminatory practices against Pakistani citizens, both to Norwegian Embassy in Islamabad and media, but the immigration rules and practices in Norway/Schengen are only getting worse.

I fear that this discriminatory visa practice against Pakistanis will continue in Norway and the Schengen states. Maybe the Pakistani MFA could again take up this issue with the Norwegian MFA and put pressure on the Schengen countries to make the visa requirement for Pakistanis less discriminatory? Personally, I do not observe real interest nor capacity from the Pakistani government to ease the problems of Pakistanis in these visa matters.

If I can give you any substantial advice what to do next if your appeal is again rejected: perhaps this issue should be brought to light again in the Pakistani or even the Norwegian media? This way, maybe the Pakistani government can sense the need to take up the issue with Norwegian authorities?
